I certify that I have all permits and/or Licenses issued by the Pennsylvania Department of Environmental Protection relating to the management, storage, and disposal of solid wastes and hazardous materials and hazardous waste.	
I certify that the Dumpster/Container will not obstruct free and clear vision, interfere with, or confuse traffic.	
I understand a Dumpster/Container placed in the public right-of-way must have a flasher or reflector on the outside corner facing traffic at all times. Where traffic may approach from either side, the Dumpster/Container must have a flasher or reflector on the outside corner on both sides. Type I or Type II barricades can be used as an alternate to flashers or reflectors.	
I understand the Dumpster/Container must be covered if, materials inside are easily airborne, pose a hazard, emit an odor or are otherwise offensive.	
I understand that in the event of a traffic hazard or congestion developing because of the Dumpster/Container, I am responsible for fees associated with Borough Police and Traffic Control.	
I understand that this list is not all-inclusive. The Borough of Millvale reserves the right to add delete and change these requirements.	
I understand that in consideration of the issuance by the Borough of Millvale of a Building or Zoning Permit to the undersigned Applicant, the Applicant acknowledges that, in reviewing plans and specifications, in issuing permits, and in inspecting work of the Applicant, employees of the Borough are only performing their duties to require compliance with the minimum requirements of the applicable ordinances of the Borough pursuant to the police power of the Borough, and are not warranting to the Applicant or to any third party, the quality or adequacy of the design, engineering or work of the Applicant. Accordingly, neither the Borough nor any of its elected or appointed officials or employees shall have any liability to the applicant for defects or shortcomings not discovered during the Borough's review or inspections. The Applicant agrees to defend, hold harmless, and indemnify the Borough, its elected and appointed officials and employees from and against any and all claims, demands, actions, and causes of action of any one or more third parties arising out of or relating to the Borough's review or inspection of the Applicant's design, engineering or work, or issuance of a permit or permits, or arising out of or relating to the design, engineering or work done by the Applicant pursuant to such permit or permits. All references in this agreement are applicable to the Applicant's employees, agents, independent contractors, subcontractors of any other persons or entities performing work pursuant to the issuance of the Building or Zoning Permit by the Borough. Furthermore, the Applicant is hereby informed that any violation(s) of the Building Code and/or the Zoning Code for the Borough of Millvale is subject to fines and penalties as stated in the applicable ordinance(s).
